- 1. Regarding Earnest Money Deposit (EMD)(Clause 5 of Notice Inviting Tender): EMD amount is now fixed to ₹ 10,00,000/-(₹ Ten Lakhs) instead of earlier amount of Rupees Fifteen lakhs.
- 2. Regarding Scrutiny and Evaluation of Tenders (Clause 12.1 (f) at page 8): may be read as follows

"Copy of agreement of Indian agent with its foreign principal describing their individual responsibilities for this tender should be attached with the bid"

- Regarding Payment Terms (Clause 33): A sub clause 33.3 is added as follows
 "33.3 A separate work order will be issued to the Indian agent for the items quoted in Indian currency with the same payment terms as detailed in Clause 33.2"
- Clause 44.8: Clause 44.8 may be read as "Automatic or external command locally and from remote"
- 5. Clause 44.21: Clause 44.21 may be read as "As the sensor is being subjected for frequent transportation, hence it should be provided with carrying case exclusively for sensor to protect from accidental drops, transport vibration and jerk"
- 6. Clause 45.2: Clause 45.2 may be read as "Flat response (within +/- 3dB) to ground acceleration, at least in the range of DC to 150 Hz"
- 7. Clause 45.16:Clause 45.16 may be read as "< 1.5 watt at 12V DC."
- 8. Clause 46.11: Clause 46.11 may be read as "Removable storage media like USB or Compact Flash (CF) card of capacity of 32GB or More"

9. Clause 50.3: Clause 50.3 may be read as following
a) Appropriate latest OS compatible to run all application software's.
b) OS license with media.

c) Anti-virus package valid upto warranty period.
